

PERSONAL CONSENT FORM

It is agreed that:

1. In allowing you to participate in the production you hereby irrevocably:
 - a) agree and consent to follow all reasonable requests of the Producer and any one delegated by them in the Programme;
 - b) agree and consent to the filming/recording of you and your voice and performance and that such film or recording may be incorporated in the Programme in whole or in part at the Producer or StoryVault's discretion and assign all rights therein to them with full title guarantee including without limitation the entire copyright and all future vested or contingent rights to which you are now or may in the future be entitled to under the laws in force in any part of the world (but you acknowledge that the Producer and StoryVault are under no obligation to use such film or recording nor to produce the Programme as a whole or in part) to hold the same throughout the universe for the full period of copyright (including all reversions renewals and extensions) and thereafter (in so far as the same shall be possible) in perpetuity;
 - c) consent to the exploitation by the Producer and by StoryVault only of the production or any part(s) of the production (including your performance) by all means and in all media and formats whether now or hereafter invented throughout the universe in perpetuity;
 - d) consent to the use and reproduction by the Producer and by StoryVault only of your performance and film or recordings of your performance or any part thereof by all means and in all media throughout the universe in perpetuity for the purposes of advertising, publicity and otherwise exploiting the production;
 - e) waive and release the Producer and StoryVault from any claim, action or demand arising out of or in connection with the production; The Producer may be held liable for loss or damage or injury to guest or guest's property suffered in connection with the making of the Programme caused by negligence of the Producer.
 - f) give all consents required by the Producer and by StoryVault and waive all rights which may be conferred on you by the Copyright Designs and Patents Act 1988;
 - g) waive all so-called "moral rights" in your performance and agree not to enforce the same or any like rights to the extent that they cannot be waived;
 - h) give all consents necessary under the Data Protection Act 1998 and other laws of personality, publicity, privacy and data protection in force from time to time

worldwide so that the Producer may include your name and likeness in the Programme and any filming of the Programme.

- i) agree not to use or disclose any information concerning the Programme and/or the Producer's business or future plans that you may acquire during the term of your participation on the Programme or at any time after your participation has ended, and you will additionally not use or disclose or aid or abet others to use or disclose any confidential information either orally or in writing for publication or not for publication by the press or any other body.
- 2. You warrant that you are fully entitled to give the consents hereinbefore mentioned and that no further consents are necessary.
- 3. The Producer and StoryVault only shall be entitled to assign or licence the whole or any part of the benefit of this letter to any third party. It is agreed that the Producer should remain liable for all its obligations unless a direct undertaking to the guest to perform the obligations has been made by the assignee.
- 4. This letter shall be governed by and construed in accordance with English Law and subject to the exclusive jurisdiction of its courts.
